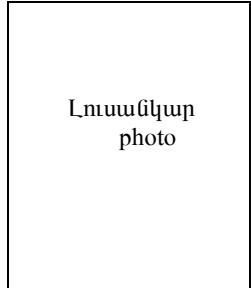
ORDINARY (BUSINESS & TOURIST) VISA

This visa is can be applied for without an invitation letter.

- passport, valid for 6 months at least,
- one (1) fully completed and signed visa application form,
- one (1) recent passport-style photograph,
- if a minor is included in the applicant's passport and is also travelling, their photo must be attached to the application,
- holders of "Travel Documents" are required to contact the Consul of the Armenian Embassy prior to applying for a visa.

Persons wishing to stay more than 120 days require an official invitation. Invitations for official travellers must be verified at the Consular Department of the Armenian Foreign Ministry; for private travellers (Visitors visa) at the Passport and Visa Department of the Police Service in Yerevan. Confirmations for official travellers are received at the Embassy in Ottawa via internet. Private travellers must submit the original invitation form.
