### **E-VISA FEES**

The visa is electronic, and is recognized by the border control computer in Bahrain upon entry. This is applicable to Canadian and those listed below only: all others must apply via courier for a passport visa.

Single Entry Visa, valid for two (2) week stay. \$20

Processing: 2 working days

## SPECIFIC VISA REQUIREMENTS FOR BAHRAIN

### **BUSINESS VISA**

- passport, valid for 6 months at least,
- one (1) fully completed and signed visa application form,
- one (1) recent passport-style photograph,
- a letter of invitation from your Bahraini sponsor, if you are not a Canadian or USA citizen,
- foreign nationals (not Canadian, US or EU) must obtain a non-objection certificate from an official Bahraini sponsor,
- an original letter (no photocopies), on company letterhead, stating the purpose and duration of the visit and that the applicant is responsible for all travel expenses.

### **TOURIST VISA**

- passport, valid for 6 months at least,
- one (1) fully completed and signed visa application form,
- one (1) recent passport-style photograph,
- a letter of invitation from your Bahraini sponsor, if you are not a Canadian or USA citizen.
- foreign nationals (not Canadian, US or EU) must obtain a non-objection certificate from an official Bahraini sponsor,

## E-VISA REQUIREMENTS

This documentation can be **faxed** for quicker service. Do not send your passport. Send copies or a fax. The visa is electronic, and is recognized by the border control computer in Bahrain upon entry.

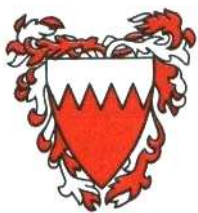
