- a letter from the company you work for, stating the purpose of your visit,
- letter of invitation from the Libyan company at which you will work..

TOURIST VISA

- passport, valid for 6 months at least,
- one (1) fully completed and signed visa application form,
- two (2) recent passport-style photographs,
- letter of invitation from a Libyan tourist company.
