*** Visa fees and times are subject to change by embassies without notice ***

VISA FEE \$38.93

Canadian citizens using Canadian passports will be issued a Multiple Migratory Form (Tourist Card) at the border for a fee of US\$20. This fee is included in most commercial airline tickets.

Residents of Canada who are legal Landed Immigrants of Canada but hold foreign passports no longer require a visa for either tourism or business purposes. You must carry your Permanent Resident Card.

Only non-residents of Canada who are in Canada require a visa. You **MUST** apply in person.
